

Re-Start Admission Policy College of Business (COB)

The College of Business recognizes that 2nd Bachelor's candidates may not have had a 3.0 or higher cumulative GPA in their first degree from CSU. As such, we will make an exception for 2nd Bachelor's candidates with less than a 3.0 cumulative GPA at the time of re-admission to CSU. This policy outlines the requirements for a GPA re-start. The calculus and microeconomics with appropriate grades requirements may have been completed prior to and/or after re-admission.

College of Business Admission Policy

Students who are currently enrolled as Undeclared Business Interest may be admitted to the COB if the student has completed MATH141, Calculus – Management Sciences or a higher level calculus course, and ECON202, Principles of Microeconomics or an equivalent course, with a grade of “B-” or better in each and has a cumulative GPA of at least a 3.0 in a minimum of 15 graded credits at CSU.

The COB Re-Start Admission Policy applies to the following students:

- Earned a Bachelor's degree from CSU Fort Collins, and have been re-admitted to CSU as a 2nd Bachelor's candidate;
- Did not meet the minimum 3.0 cumulative GPA requirement for direct admission to the COB upon re-admission to CSU; and
- Have been admitted into Undeclared Business Interest.

Re-Start Admission Policy

- 2nd Bachelor's candidates who were admitted into Undeclared Business Interest will be allowed to Re-Start their GPA for purposes of COB admission only.
- Students must meet all College of Business admission requirements identified above, but will be allowed to Re-Start their GPA beginning their first semester back at CSU.
- GPA Re-Start will not be tracked by university systems such as Aries, but instead, it is the student's responsibility to track their own GPA and attend a COB Change of Major event when they have established a minimum 3.0 cumulative GPA in a minimum of 15 graded credits, completed since re-admission as a 2nd Bachelor's candidate.
- When students attend a Change of Major event, the COB will confirm that the Re-Start GPA is a minimum 3.0 in a minimum of 15 graded credits. The College of Business will also confirm that the student has completed the appropriate Calculus and Microeconomics courses with the required grades (during first bachelors or after re-admission to CSU).
- University systems such as Aries continue to track a student's overall cumulative GPA. Ethically, students should report their cumulative GPA on resumes and to potential employers.

Change of Major event

- The COB offers a Change of Major event at the end of each fall, spring and summer semester, once grades have been officially posted. Students can get the date, time, and location of the next Change of Major event from their assigned CASA Advisor, or at <http://biz.colostate.edu/undergraduatePrograms/admissions/pages/default.aspx>.

The COB reserves the right to re-evaluate and potentially change this policy at any time. Although several Colleges have similar policies, no policy is the same. The COB will only honor this policy, as written, and will not make any exceptions to the requirements identified within this policy.
