Clinical Professor of Computer Information Systems

The Department of Computer Information Systems invites applications for the position of Special Appointment-Clinical Professor of Computer Information Systems. This is a 9-month non-tenure track special appointment position with benefits and a renewable contract of three years. The purpose of this position is to supplement the expertise of the tenure track faculty and concentrates on the more technical courses including computer programming. The teaching load for this position is 8 courses to be determined by the department chair. In particular, this position addresses teaching needs in the area of Computer Information Systems. Additionally, candidates will be expected to participate in service activities. Specific responsibilities include: Teaching technical courses in the undergraduate and graduate programs, including in the Business minor, and potentially in the College's MBA programs. Evening and on-line teaching may be required. Clinical Professors are responsible for all aspects of course delivery, including syllabus production, lecturing, meeting with students, and assigning final grades. Some courses have multiple sections and several instructors/lecturers/professors, and thus instructors are required to coordinate syllabi and grading standards.

Responsibilities: Deliver instructional course material via multi-media teaching techniques in relevant subject areas in prescribed delivery format. Construct course syllabus adhering to College of Business assurance of learning outcomes and departmental standards. Administer course through Colorado State University's learning management system. Percentage of time: 90%.

Serve on Committees at departmental, college and university levels. Serve the discipline through activities such as committee membership on academic society committees and reviewing for journals and conferences. Percentage of time: 10%

Required Qualifications:

Applicants must have a terminal degree (Ph.D., DBA) in Computer Science or Computer Information Systems or a closely related discipline. Applicants must also have a demonstrated ability or potential for quality teaching and have multiple semesters of experience teaching in a college of business. Excellent written and oral communication skills, flexibility, and collegiality are essential. Ability to effectively coordinate with other faculty members and contribute to improving the content and delivery of the departmental courses is also required.

Preferred Qualifications:

Preference will be given to candidates with awards or recognition for quality teaching, experience with course design, experience as lead instructor in at least 3 different courses, experience with specific SW platforms including Java, JUnit Testing, Windows and Linux system administration, bash, Powershell, VMware vSphere, and TCP/IP networking. Experience with computer security, and evidence of active learning and scholarship.
